A real-time AI-powered sustainability analytics tool that provides predictive maintenance, optimizes energy use, and supports circular economy transitions, enabling manufacturers, and regulators to make data-driven decisions.

Beyond State of the Art

The tool combines industrial efficiency with AI-based sustainability governance. It provides predictive maintenance and industrial defect prevention capabilities, reducing downtime and waste. The AI-Analytics Designer integrates participatory governance functions that allow local authorities to track emissions, enforce Local Green Agreements and align industry with climate goals. It promotes industrial symbiosis by identifying opportunities for converting waste into AI-based resources, and ultimately provides a replicable AI-based governance model in peri-urban carbon reduction efforts.
